## New KMIT Payroll Auditing Process

KMIT is implementing an <u>upgraded (improved) payroll auditing process</u>, and it has nothing to do with all the other changes going on with the pool. It DOES have to do with a new partner in our payroll auditing system. Last summer, KMIT began a relationship with Legacy P&C Partners, LLC. (legacypcpartners.com).

The KMIT payroll auditing process takes place early in each year, typically starting about mid-January. The work to be done in early 2013 will be to determine each city's actual payroll amounts for 2012, so that close-out calculations/ adjustments on 2012 premium payments can be made by KMIT.

From now on, KMIT's **payroll audits** will all be completed via email. No



more 'desk' audits for any city in the pool. All information will flow from cities to the auditor via email, fax and US Mail.

The one VERY IMPORTANT thread in our KMIT process is our long-time payroll-auditing 'guru', **Carma Drehle-Neth**, who will now personally complete <u>all the KMIT payroll audits</u>. In other words, ONE auditor will complete all the KMIT audits; there is no longer a team of auditors.

Carma has already contacted all our cities (in late November), and established lines of communication, via personal phone calls to each and every KMIT member city, followed up with a letter to each city. Carma has pointed out that those positions which are 'split' on the payroll sheets will need to be given to Carma via a percentage allocated to the different applicable class codes. #### KMIT 2013 Work Comp Premium Invoices Sent

KMIT mailed out its annual renewal quotes and invoices on November 30, so most KMIT member cities received the 2013 premium notice in the mail on or about Monday, December 3. (If you haven't seen your 2013 premium invoice, please contact Deanna Furman or Don Osenbaugh right away.)

Due to some 'tweaking' of its calculation methodology, NCCI (the national rating agency) is distributing its *experience modifier* (mod) ratings a bit later than normal, and KMIT mods were received too late for our initial billing requirements (see reference to this point in your renewal letter from KMIT). <u>This fact has resulted in having to re-issue corrected quotes</u> and invoices to a number of our KMIT cities. This need to re-issue quotes been an unexpected hurdle.

KMIT premium payments for 2013 are due and payable-in-full on or before January 31, 2013.

Be sure to remember:

- 1. Checks are to be made payable to 'KMIT';
- 2. Checks MUST be mailed in care of KMIT's special lockbox

<u>address</u>. Please make sure to change your your vendor/address; this address has changed. The current lockbox information is provided on the invoice and the quote.

### What You Need To Know

When workers are using new equipment for the first time, make sure they are:



Trained on the same equipment they'll be using. They shouldn't be getting to know it on the job.

Given expert guidance. Try getting your equipment providers to pitch in with training.

Supervised closely. Keep an eye on workers until you're sure they're comfortable with new equipment.

## **KMIT Annual Meeting Recap**

KMIT held its **19<sup>th</sup> Annual Meeting** in Topeka on October 7 (during the LKM Conference). The meeting was presided over by **KMIT President Larry Paine** (Larry became President in June, following the resignation of Daron Hall; he will continue on as President of KMIT until October 2013).

A total of 109 city officials attended the Annual Meeting, representing 45 of the 147 member cities of KMIT. Trustees re-elected to continue to serve (an additional two-year term) included: Larry Paine (Hillsboro), Herb Llewellyn (El Dorado), Debra Mootz (Roeland Park), Keith Schlaegel (Stockton) and Tim Hardy (Elkhart).

Risk Control assessment ratings of **GOLD were** awarded to 67 KMIT cities; ninteen cities got a Silver



rating and thirteen received a Bronze. The City of Lenora was recognized for being a member for 15 years; and eight cities (Augusta, Columbus, Great Bend, Horton, Leoti, Lincoln Center, Satanta and Stockton) received their 10-year awards. The **EIGHT new cities to KMIT in 2012** were recognized—Belle Plaine, Benton, Chapman, Lindsborg, Moundridge, Scranton, Sylvan Grove and Westwood.

The primary topic of the meeting was a **Bylaws Amendment**, which formally separated KMIT from the League. Prior to a vote, **LKM Executive Director Don Mole**r spoke in favor of the move, and explained the process that has gone on and the <u>'MOU' that sets in motion a five-year agreement of cooperation between the two entities</u>. President Paine asked for and received a unanimous vote of approval by acclamation.

The next KMIT Annual Meeting will be during the LKM Annual Conference, in Overland Park, in October 2013.

# Garden City Becomes Newest Member

On November 6, the Garden City City Commission voted to join the KMIT work comp pool, thus, Garden City officially becomes a part of the KMIT family on January 1, 2013.



With a population of 28,451 (ranking 13<sup>th</sup> in Kansas), and with 305 employees, Garden City is the largest city ever to be a part of KMIT. Welcome to KMIT, Garden City!

# NCCI 'Split Point'

As mentioned elsewhere in this missive, and in the renewal letters sent to all KMIT cities along with their 2013 quotes and invoices, the national rating agency that calculates the *experience modifier* ('mod') ratings for all cities and businesses in Kansas, and in most other states as well, NCCI (the National Council for Compensation Insurance), is in the process of revising its intricate (ie, 'complicated') mathematical methodology for determining mod ratings.

In short, the 'tweaking' of the NCCI model, dubbed 'Split Point' by NCCI, is in the <u>first year of a three-year process</u>, which is designed to adjust for the fact that the average cost of medical claims has gone up significantly since the last change in the process, some twenty or so years ago. This 'tweaking' of the process is <u>resulting in mods going up and down more than usual this year</u>, and there is really nothing KMIT (or any private-market company) can do about it, except to adjust as we go.

### **Training Tips!**

#### Get staffers to participate in safety training

Most safety professionals know folks are more likely to remember information if they participate during training. So try asking asking different questions to increase participation.

**Instead of:** "Does anyone have any questions?" **Try:** Picking out one worker and asking him or her, "What questions do you have about this?" That will help engage workers, and keep them paying attention.

#### Eye injury simulation

Here's a simple way to get workers to take eye safety seriously: At your next training session, have your staffers take turns wearing safety goggles with Vaseline smeared on the lenses. That will show them what the world will look like if they suffer an eye injury.
