Safety Glasses DO Matter...Please Use Them!! A KMIT Case Study By Lori Moore, City of Atchison

I don't know how many other KMIT Cities have reported foreign body eye injuries, but I assume it to be a fairly common occurrence for those charged with submitting the 'Employer's Report of Accident' to Victoria (our claims adjuster). Over the years, I have submitted numerous reports where an employee got something in their eye and, because of the frequency of this type of incident, the matter is usually dismissed as a minor accident. Of course, employees are counseled on their failure to wear appropriate personal protective equipment, but because, either: the safety glasses were 'uncomfortable', the job was just going to take a minute, the glasses were left in the truck, or for whatever excuse; in many instances, unfortunately, safety glasses were not worn.

The purpose of this message, however, is to relay just how catastrophic an apparent 'minor' eye injury can become. On October 2, 2005, a seven-year veteran of our street department was working with another employee to strip a wooden form from a concrete inlet. The employees were using a hammer to dislodge the form when the employee felt something hit his eye. At the time, he said it felt like it had hit the inside bridge of his nose next to his right eye. He indicated that he joked he didn't want to drive that day, because looking out of his eye reminded him of looking through a kaleidoscope, and he described seeing pretty colors. He reported the accident, and stated that if his eye bothered him the following day he would see a doctor. In the early morning hours of October 3rd, he started having severe pain, and went to the local hospital emergency room, where he was examined, and diagnosed with a perforation to his eye. He was immediately sent to KU Medical Center, where surgery was performed on his eye to remove the object.

Apparently a piece of metal, possibly from the hammer (a little bit larger than the size of a bb), went through the center of his eye, shattering the lens, then hit the inside bridge of his nose before it spun around, similar to a buzz saw, behind his eye. Additionally, a severe infection had already begun in the eye, complicating the matter—requiring further surgical procedures described to me as 'scraping' the eye, in order to prevent the infection from spreading to his left eye.

Unfortunately, the employee has lost all sight in his damaged eye, and is currently being fitted for a prosthetic eye. This employee has maintained his usual great outlook on life, and hasn't uttered one complaint to my knowledge. He's even offered to show me his eye (an offer I had to refuse). But, I can't help thinking that, if it had been me, I would have much rather reached for my safety glasses than the black patch he is currently wearing.

Supervisor Training Seminars

The annual **KMIT Supervisor Training Seminar** series resumes in February 2006. This highly successful one-day training is intended for *all* 'supervisors'—from lead persons, to division and department heads, to city clerks, police and fire chiefs, city superintendents, city managers, and any and all others who supervise employees.

The training is actually broken down into standalone, ½-day sessions, covering *risk control/ management* (morning session) and *work comp management* (afternoon). KMIT's professional partners at IMA are the primary presenters at both sessions, in conjunction with League staff.

The 2006 Seminars will be held at three sites: **Concordia** (Thursday, February 9), **Arkansas City** (Thursday, February 16) and **Parsons** (Thursday, March 2). Registration flyers and other reminders will be sent out early in 2006, but please mark your calendars now. These are excellent training sessions for supervisors, and are VERY affordable.

Safety Olympics Replaced by New Program

At its meeting in De Soto on December 9, the KMIT Board of Trustees unanimously approved changes to the pool's safety certification program, and gave the new program a new name: *Loss Prevention Certification Program*. The new name reflects the fact that the new program, while continuing to emphasize safety as the best way to prevent loss in the first place, adds a number of other criteria which significantly contribute to an excellent overall work comp loss prevention approach, as stressed by KMIT.

KMIT's loss control partners at IMA will provide details of the new program in the mail soon. Look for a full story on the *Loss Prevention Certification Program* in the next issue of this publication (due out in February).



Welcome Back, Marcia Payne

Marcia Payne, who worked with our KMIT cities for a number of years, before 'moving on' in 2004, is back—working with two companies that interact with KMIT and IMA on various claims-related services.
